Request to speak at public comment segment of meeting of the Council

Dear Mr. Sandoval:

I would like to speak at the meeting of the Fair Employment and Housing Council during the public comment segment on Agenda Item XII regarding Section 11135 regulations.

As you know, Government Code Section 11135 prohibits state agencies and state-funded programs from discriminating on the basis of disability. The statute incorporates into state law Title II of the federal Americans with Disabilities Act. The ADA and Section 11135 apply to state courts. This includes proceedings in probate conservatorship cases – all of which involve involuntary litigants with serious cognitive or communication disabilities.

Because of their disabilities, these individuals depend on judges and court-appointed counsel to protect their rights, including their rights under Section 11135 and the ADA. Unfortunately, our research indicates that judges and attorneys act as though these nondiscrimination provisions do not apply to conservatorship proceedings.

Due to the nature of their disabilities, these litigants would not know that their rights are being violated. This lack of awareness, and their inability to file complaints on their own, allows disability discrimination to continue unabated or unchecked. This is why the involvement of the Department of Fair Employment and Housing is so important. Having a set of regulations that informs judges and attorneys, in no uncertain terms, of their duties and of the rights of these litigants is crucial to the effectiveness of Section 11135. It is also important for the Department itself to have guidance.

We anticipate the day when clear and detailed regulations for Section 11135 are released for public comment. We urge the subcommittee and the full Council to ensure that the regulations leave no ambiguity about the duties of judges and attorneys to respect and protect the rights of litigants with disabilities in conservatorship and other judicial proceedings.

Please share this email with other members of the Council and staff. I look forward to addressing the Council on March 19.
